The new system is more difficult and Kelli has an appointment with County Side Accountants to have someone that is familiar with the new system come out and train her on the 15th. The report to the county must be turned in by the 30th and with the training she will have it in on time. The report is extremely important because without it, we do not get our Act 51 grant money. Susie made a motion to allow the accountant to come out and do the training. Will seconds. 5 yays and 0 nays. Motion carries. 4) Kelli would like to open 2 CD's. One from the General account and one from the Sewer account. Once the general account is paid back from major and sewer, it will have over \$300,000.00 and the CD's are doing very well at this time. Sherry made a motion to have Kelli purchase the CD's for both accounts. Susie seconds. 6 yays and 0 nays. Motion carries. Motion to accept the Treasures Report made by Susie and second by Pam. 6 yays 0 nays. Motion carries.
